

Not late....Not late.....for a very important date!



"Hacking STEM" Summer Camp

Summer, 2019

Campers will be mentored by UNF Students participating in Intercollegiate, collaborative, and authentic STEM projects. Campers will have the opportunity to learn coding, hacking, and making skills in computer science, engineering, and advanced applied mathematics while building STEM tools to participate in grade-level-specific projects related to our STEP Lab Social Justice projects.

JUNE 3-7, 2019: (Grades 3-6) HACKING AGRICULTURAL RESOURCES

Elementary School students will be engaged in Hacking Stem Lessons, Minecraft Edu., and Lego Robotic lessons that will integrate STEM curriculum. Students will build trundle wheels, learn to interpret streaming data, and learn to build and interpret 3D models of drone photographic data. Students will construct actual organic gardens, thereby learning the math, science and technology associated with this task. We will give consideration for equitable food distribution and production in rural communities.

JUNE 10- 14, 2019: (Grades 6-9) HACKING WATER RESOURCES

Middle school students will be engaged in Hacking Stem Lessons, Minecraft Edu., and Lego Robotics, along with WozU drone and integrated STEM lessons. Students will build dissolved oxygen sensors and sonar equipment. They will learn to 3D model waterways and river bottoms- essentially conducting civil engineering projects. JUNE 17-21 & 24-28: (Grades 9-12) HACKING MEDICAL RESOURCES

High School students will be engaged in Hacking STEM Lessons, and roboticsintegrated STEM lessons. Students will build robotic hands, 3D- printed hands, and invent robotic 3D-printed assistive technology for specified individuals from our community.

Welcome to new students and welcome back to VRA for 2019-2020!

KG Registrations - Beginning on March 1, 2019, you will be able to go online to Pre-register your Kindergarten (KG) student. <u>There will not be any on-site registration dates.</u> All KG registrations and required documents must be completed and uploaded via the Online Registration system. Please visit the Valley Ridge Academy website and go to the Registration Tab for detailed instructions.

Attention All 6th Graders - The Tdap immunization shot is required for all 7th graders and must be recorded on a Florida 680 form. As soon as your student receives this shot, the form can be brought to the front office, faxed (904-547-4095) or emailed (to <u>paige.lange@stjohns.k12.fl.us</u>) even if the student is still in 6th grade. <u>Per district policy, all</u> 7th grade students that do not have this shot will not be allowed to start school the year they are entering 7th grade. Please contact Paige Lange, Registrar at 904-547-4096 with any questions.

Rising 6th and 9th Graders - In preparation for middle and high school registrations, all rising 6th and 9th grade students will be required to update their residency items. This will be facilitiated through VRA's Online Registration system by uploading your residency documents. Information regarding this process will be sent out in the next few weeks. Here is a list of the items that will be required:

- 1. Mortgage Statement/Property Deed/HUD or Lease
- 2. Utility bill (FPL, JEA, TECO, Internet)
- 3. One more bill (Additional utility, cellphone statement, vehicle registration, insurance documents).

SUMMER MARINE SCIENCE PROGRAM

Parents,

Applications for the summer Marine Science Program were passed out at all schools during the week of February 12th. Applications were due back to science teachers by February 28th. Applications can still be downloaded at any time from the website prior to April 15th at http://www-grms.stjohns.k12.fl.us/marinescience/ The link also will have a complete day by day curriculum for each grade level, parent information, and a video from last year's program.

This summer program is available to all students currently in grades five through seven and has been sponsored by the school district since 1982. Three eight day sessions are held at Gamble Rogers Middle School with bus transportation provided. The dates for the three sessions this summer will be May 29th through June 7th, June 10th through June 20st, and June 24th through July 3rd. Small classes of 13-15 students are separated by grade level. All instructors in the program are St. Johns County School District teachers.

The Marine Science Program is a carefully designed experience for responsible students who are interested in learning about our local marine environments. Learning is "hands on" in the field with students kayaking, canoeing, boating, hiking, snorkeling, sailing, windsurfing, surfing, SUP, (stand up paddleboarding), etc. Specific grade level activities and curriculum are attached to the applications and are also available from the website.

Reminders from the Dean's Office:

SJCSD Student Dress Code

(2018-19 SJCSD Student Code of Conduct, pages 13-14)

The dress and grooming of St. Johns County Public Schools students shall contribute to the health and safety of the individual promote a positive educational environment and not disrupt the educational activities and processes of the school. Because inappropriate clothing worn by a student is detrimental to the school program, the wearing of garments suitable for school shall be encouraged. All faculty and administrative staff shall be on the alert to give positive guidance in these matters, without embarrassment to the student.

These rules on personal appearance of students are intended to enable the students of St. Johns County Public Schools to dress casually but reasonably. However, the school principal is the final authority with regard to the appropriateness of student dress. **Nothing in these rules shall be construed to pre-empt the principal's authority** to act in specific cases when, in the principal's judgment and discretion a student's dress threatens to disrupt the educational process or the good order and discipline of the school, or is otherwise inappropriate.

All Students

- Personal attire may be in the style of the day, but clothing that is immodest, revealing, or distracting in character is unacceptable. Clothing, piercings and accessories shall not be worn if they display profanity, violence, discriminatory messages, sexually suggestive phrases, advertisements, phrases or symbols of alcohol, tobacco or drugs or create a safety issue within the learning environment.
- Students are prohibited from wearing clothing that exposes underwear or that exposes body parts in an indecent or vulgar manner.
- Head coverings, including but not limited to, caps, hats, bandannas, and/or sunglasses, shall not be worn on campus unless required by a physician or authorized by school administration.
- Students must wear shoes that are safe and appropriate for the learning environment. Middle school and elementary school students must wear shoes that have a back or strap on the heel.
- Skirts, dresses, shorts, baggies, no shorter than four inches (4") above the top of the knee, are acceptable. Skirts shorter than four inches (4") above the top of the knee worn with tights are not acceptable.
- Leggings and yoga pants are acceptable but must worn with a shirt, dress or skirt that reaches fingertip length.
- Graffiti (i.e. profanity, violent or discriminatory images, sexually suggestive phrases or symbols, or symbols of alcohol, tobacco or drugs) will not be drawn or worn on backpacks, notebooks, folders, yearbooks, papers, clothing or any other object or on the body of any student or person on school property.
- Sleeveless shirts and tank tops are not acceptable.

Standards: Boys

- Boy's pants/slacks must be worn at the waist. No boxer shorts or underwear may be visible.
- Shirts must cover the entire shoulder.

Standards: Girls

- Tops and shirts must cover the entire shoulder and may not be revealing or distracting. Midriff or "cutout" dresses and "cut out" tops may not be worn. Skirts must be no shorter than four inches (4") above the top of the knee. Revealing clothing, pajamas and lingerie are not acceptable. Undergarments must not be exposed.
- Girls' pants/slacks must be worn at the waist. No underwear may be exposed.

Cell Phones and Electronic Devices

The use of electronic devices, such as cell phones, electronic readers, hand-held video games, etc. is prohibited during school hours.

- If such items are brought to school, they must be placed in the student's locker, backpack or purse during the normal school hours. Items are to be **turned off**.
- Students may not use cell phones to make phone calls or text message during school hours. This includes during classes, between classes and/or lunch. Students found using their cell phones during school hours will have their phone confiscated. Repeated failure to comply will be considered defiance of school rules.
- If a phone call must be made, phones are available in the main office.
- Students may not use their cell phones as entertainment during the school day. This includes playing games, going online, checking time, etc.
- Students are not permitted to use camera phones for the purpose of taking pictures in school or on buses.

Cheating:

- If a student is caught using a cell phone or other form of technology to aid them in cheating, he/she will have the appropriate penalties for both cheating and cell phone use applied to them.
- Texting or checking texts during a test/exam will result in the student receiving a zero for the test/exam.

KNOW KNEKS BURGER Talk with Your Teen About E-cigarettes: A tip Sheet for Parents

BEFORE THE TALK

Know the facts.

 Get credible information about e-cigarettes and young people at E-cigarettes.SurgeonGeneral.gov.

Be patient and ready to listen.

- Avoid criticism and encourage an open dialogue.
- Remember, your goal is to have a conversation, not to deliver a lecture.
- It's OK for your conversation to take place over time, in bits and pieces.

Set a positive example by being tobacco-free.

 If you use tobacco, it's never too late to quit. For free help, visit smokefree.gov or call 1-800-QUIT-NOW.



START THE CONVERSATION

Find the right moment.

- A more natural discussion will increase the likelihood that your teen will listen. Rather than saying "we need to talk," you might ask your teen what he or she thinks about a situation you witness together, such as:
 - » Seeing someone use an e-cigarette in person or in a video.
 - » Passing an e-cigarette shop when you are walking or driving.
 - Seeing an e-cigarette advertisement in a store or magazine or on the internet.



Ask for support.

- Not sure where to begin? Ask your health care provider to talk to your teen about the risks of e-cigarettes.
- You might also suggest that your teen talk with other trusted adults, such as relatives, teachers, faith leaders, coaches, or counselors whom you know are aware of the risks of e-cigarettes.
- These supportive adults can help reinforce your message as a parent.

ANSWER THEIR QUESTIONS

Here are some questions and comments you might get from your teen about e-cigarettes and some ideas about how you can answer them.

Why don't you want me to use e-cigarettes?

- Science shows that e-cigarettes contain ingredients that are addictive and could harm different parts of your body.
- Right now, your brain is still developing, which means you are more vulnerable to addiction. Many e-cigarettes contain nicotine, and using nicotine can change your brain to make you crave more nicotine. It can also affect your memory and concentration. I don't want that for you!
- E-cigarettes contain chemicals that are harmful. When people use e-cigarettes, they breathe in tiny particles that can harm their lungs.

 The cloud that people exhale from e-cigarettes can expose you to chemicals that are not safe to breathe.

What's the big deal about nicotine?

- Your brain is still developing until about age 25. The Surgeon General reported that nicotine is addictive and can harm your brain development.
- Using nicotine at your age may make it harder for you to concentrate, learn, or control your impulses.
- Nicotine can even train your brain to be more easily addicted to other drugs like meth and cocaine.

 I don't say this to scare you, but I want you to have the facts because nothing is more important to me than your health and safety.

Aren't e-cigarettes safer than conventional cigarettes?

- Because your brain is still developing, scientific studies show that it isn't safe for you to use any tobacco product that contains nicotine, including e-cigarettes.
- Whether you get nicotine from an e-cigarette or a cigarette, it's still risky.
- Some e-cigarette batteries have even exploded and hurt people.

I thought e-cigarettes didn't have nicotine – just water and flavoring?

- I used to think that too. But many e-cigarettes have nicotine. There are also other chemicals in them that can be harmful.
- Let's look at the Surgeon General's website on e-cigarettes (E-cigarettes.SurgeonGeneral.gov) together so you can see for yourself.

l (or my friends) have tried e-cigarettes and it was no big deal.

- I appreciate your honesty. In the future, I hope you (or your friends) will stay away from e-cigarettes and other tobacco products, including cigarettes. Science shows that e-cigarettes contain ingredients that are addictive and could harm different parts of your body.
- Next time we go to the doctor, let's ask about the risks of nicotine, e-cigarettes, and other tobacco products.

You used tobacco, so why shouldn't 1?

- If I could live my life over again, I never would have started smoking. I learned that people who smoke cigarettes are much more likely to develop, and die from, certain diseases than people who don't smoke. This was really scary, so I quit smoking.
- Quitting was really hard, and I don't want you to go through that. The best thing is to not start at all.



KEEP THE CONVERSATION GOING

Many parents find that texting is a great way to reach their teens. Here are some suggestions for text messages that might catch your teen's attention. And, you can easily share pages of the website (E-cigarettes.SurgeonGeneral.gov) with your teen.



Lock for this symbol, click it, type in the message you want or use the message provided, and share with your teen via Facebook, Twitter, or email.

Connect and encourage.

- You always liked science. Check out the science about e-cigarettes and young people E-cigarettes.SurgeonGeneral.gov
- Getting off nicotine is hard but I'm so happy I quit. Don't make that mistake and get addicted. Smoking and tobacco use, including using e-cigarettes, are unsafe for young people.

Remind and repeat.

- Most teenagers don't use e-cigarettes. E-cigarettes with nicotine can mess with your brain, and your brain is still developing until you are at least 25.
- You might be tempted by e-cigarette flavors, but inhaling certain flavorings that have been found in some e-cigarettes can be harmful.

Share facts and resources.

- Just learned that many e-cigarettes have nicotine in them. That's the drug that makes cigarettes so addictive. Nicotine can also mess with your brain development.
- Just saw a report from the Surgeon General that e-cigarettes can mess with how your brain develops and might even affect your mood and focus. Please don't use any products that contain nicotine.
- Hope none of your friends use e-cigarettes around you. Even breathing the cloud they
 exhale can expose you to nicotine and chemicals that can be dangerous to your health.
